ROANOKE REEF CASE IS APPEALED

At the last general meeting on April 19, the issues and finances pertaining to the lawsuit against the man-made reef were reviewed, and it was resolved that we go ahead with the appeal. The appeal was filed by our attorney, handed down by the US Supreme Hal Green, and the State of Washington the next day.

Part of our concern was that the public agency, the state, who came in to protect the public interest through the Shoreline Management Act, had not committed themselves substantially to the appeal. We met with them prior to the general meeting and were encouraged by their taking more responsibility.

The tremendous amount of work done by members of the Council in canvassing the neighborhood, and reaching out to other groups and indi-viduals, and the response we received both inside and out side the neighborhood, backed up our confidence in the worth of the appeal, and brought it financially within our grasp. What began as an attempt to

stop a totally undesirable monolith from growing on our shores has become an issue that affects many more people than ourselves. .

The Sierra Club decision Court a few weeks ago sets guidelines for groups in court action. It states that an organization must prove damage to its members, which we did in court. It may help is in our case.

While things look positive on the appeal, we are still in need of funds for the appeal.

This is not a small 8- or so-unit apartment going up: it will have 112 units. That means 112 more cars to increase traffic on already crowded narrow streets. It means increased overload on the sewer system. It means than anyone living in the corridor behind the building, all the way to Boylston, will have views affected if not totally blocked. And that means that anyone who paid for view when he bought his property, will not get his money out of it if he goes to

For those of us who do not live in the corridor, our rights to use of the water are severely limited; our view from the shore might as well be toward a retaining wall; and our confidence in the ability of the law to protect citizens will be considerably eroded.

1 tsp. baking soda 1/4 tsp. mace
