- I OPEN DISCUSSION on Planning and Programs, Policies and Purposes for 1974. This is a Special Meeting for the Eastlake Community. At the March meeting interested persons, as well as current members; are asked to make a special effort to attend on the 19th. The Eastlake Community Council is concerned with the quality and tone of life in our immediate community, and how our goals and aspirations can be reflected in the larger community in which we live. This is a highly energetic and diverse community, but the success of the community is directly dependent upon the ability of its members to participate as a whole. For this reason, the members of the community are asked to come together at this March meeting to plan programs and to suggest policies for the coming year. Ask yourself, by what means can the Eastlake Community Council become more effective? What do you want from your community? Please be prepared to contribute to a productive discussion as to help to formulate the stuff that makes for a sense of community. - II TRAFFIC: Some new information has come to light concerning the longstanding debate between the Engineering Department and the Eastlake Community. The Eastlake proposal concerns a cul-de-sac arrangement on Pairview, two-way traffic on Roanoke between Franklin and Boylston; signals at Roanoke and Eastlake and the resurfacing of parts of Fairview. This proposal will be analyzed considering the new developments. The possibility of reinstating the Traffic Committee will be discussed.

MEET THE FREEHOLDERS: On March 23d, between noon and seven the voters of the City of Seattle will have the opportunity to see, talk to, compare indorsements of, and listen to all the Freeholder Candidates all under one roof. The Freeholders Fair will be held at the Seattle Center in the Flag Plaza Pavilion. The Central Seattle Community Community Council Federation, The League of Women Voters, CHECC, The Municipal League, and others are sponsoring this event (with a Tittle help from ECC).

COMMUNITY BULLETIN BOARD, Complements of RANDY RUSSELL: Outside the Eastlake Zoo, at Lynn Street, now hangs the first and foremost Eastlake Community Council Bulletin Board. Notices of public hearings and Eastlake events snuggly buffet the cross currents of community communication and the chance happenings of City Hall. Additional monuments to the concerned citizens of our community should soon dot our urban landscape. Without Randy's contribution of talent and materials, this inauspicious beginning would not have been possible. Besides that, his example is an inspiration to us all. So inspirational that the EASTLAKE COMMUNITY COUNCIL NEWS has decided to proffer for the first time The Pillar of the Community Award for Exceptional & Highly Esteemed Service. To Randy Russell, carpenter, woodworker par excellence and friend. Honorable mention goes to Mike and Ivan for their services during the creation, and to Paul and Brad of Zepplin Studio, temporarily used for this purpose. Rumors that Randy, a nice Italian boy from Wyoming, keeps a coyote and a cougar, lean as spagetti and mean as garlic, is totally unfounded at this writing. We do know that Randy has done us a fine service. To the carpenter then, Pillar of the Community, our thanks.

PRECINCT CAUCUSES: On March 5th, the Democrats and the Republicans held their offyear caucuses. Those in the Eastlake Community were not attended as during the Mc-Govern era, when houseboats were packed to sinking. These uneventful times nontheless brought forth a few good souls. The ECC NEWS contacted Gretchen de Grasse on the democratic side, and Barbara Schlag of the republican. The following reports were gathered from these women, reflecting the concern of each for an increased local commitment to this channel of communication.

*Republican Caucus at Barbara Schlag's: It was an opportunity to formulate rather than simply approve or disapprove of the final result of the County, State or National platform and its standard bearers. The process at the precinct level was both stimulating and gratifying for those attending the Republican Caucus. The Republicans gathered on the same evening as the Democrats to investigate the question of im impeachment, capital punishment, the structure of the legislature, revision of tax laws and many other issues of national, state and local focus. Opinions were recorded and submitted to the Republican Party for the development of future policy. *Democratic Caucus at Gretchen de Grasse's: Discussion began with the consideration of local issues such as Woodland Park, The Arboretum, Sand Point and the issues on the ballot March 26th. Official party business began with voting on issues to be on the agenda of the County, State and National Democratic Party Conventions. A questionare was circulated concerning in part: 1)Should an excess-profit tax be leveled on oil companies, 2) should the state legislature be a full-time job, and 3) should President Nixon be impeached. Delegates to the 43d District Legislative Caucus and the King County Democratic Convention were elected. Those elected were Cathy Garrison Garrison and 'Ann McGuire.

Then the fun began, the adoption of resolutions by the 49th Precinct. Briefly, they were as follows: 1)Trident should not be located on Puget Sound, 2) electronic surveillance shall not be conducted without a warrant, and any evidence so gathered be deemed unlawful oil depletion allowances be discontinued and the nationalization of oil be considered, 4) consideration be given to alternatives to nuclear power plants, 5) that the Democratic Party support a graduated income tax based on the federal structure, 6) that medical and dental care be provided for all, 7) that the federal government immediately subsidize mass transit systems and 8) that the Equal Rights Amendment be ratified by all states.

LAKE UNION BIKE TOUR will be led by Dan Reiss on Sunday, March 17th. The tour will form at Smitty's Pankake House at 9AM for coffee. It will then circle and cycle southbound noting points of difficulty in the proposed bikeway plas as presented at our last meeting. Roanoke Bay, the City Light Steam Plant bridge, problems with rail crossings and other space and use problems will be experienced by these hearties. Don't miss the Fremont Bridge entry hassle, the Gas Plant Viewpoint, the expanse of Northlake Way and the University Bridge traffic dodge. Of additional interest to community minded folks: There will be a lot of Cascade Community Council people taking part, as many that is that can get across Mercer Street in one piece.
