LAKE UNION 'CIRCLE RIDE: On Sunday June 16th, Dan Reiss (EA 2- 2961) will lead a tour around Lake Union. Cyclists should meet at Lynn Street Park at 9:30am for a ten o'clock departure. The six mile trip should take about two hours with a stop at the Steam Plant Bridge for a description of the City's new bike trail and chow at Ivars on the way.

The Lake Union Bikeway will be a feature of this tour. Budget allocations amount to \$50,000. The features included so far are: 1) Exclusive bike lane on Power Plant Bridge, 2) Improvement of access from Westlake to the South end of the Fremont Bridge, 3) 40th Street lane designation striping and connection to the Burke-Gilman Trail.

UPDATE, ROANOKE REEF: Contrary to what many may believe from looking at the dormant slab of concrete at the foot of Roanoke, there are people behind the scenes gearing up for another attempt to raise the monolith in Roanoke Bay. The units are still being sold!

The court has ruled, and the Corporation Counsel of the City concurs, that an Environmental Impact Statement (EIS) must consider the impact of the existing pilings and platform, as well as the structure to rise above. The EIS issued last fall considered only the proposed superstructure.

The Department of Community Development is currently writing the EIS to fulfill the requirements of the courts. But it appears that this new part of the impact statement (that covering the part of the Reef already built) will not be subject to public review. A policy decision has been made that the Planning Commission will not hold a public hearing to review the addition to the EIS. It will instead be sent directly to the City Council Planning Committee where the final decision will be made as to whether the Reef will or will not be built.

A letter has been sent by Phil Keightly on behalf of the ECC to the Department of Community Development protesting the irregular - to say the very least - procedure. Other letters should be directed to Mr. Bob Hintz, Office of Environmental Management, Department of Community Development, Artio Bldg, 98104, and Mr. Cal McCune, Chairman of the Planning Commission. For the present it's a game of wait and see. Our attorney is aware of the situation. We will keep you informed. The issue is far from dead yet.

THE SHORELINES MASTER PROGRAM, developed by a citizen's advisory group over a period of eight months last year has a competitor. A proposal has been worked out by a group of business interests that call themselves the Western Environmental Trade Association of Washington.

This proposal compares the existing plan with its own, and on a cursory glance, it appears that height and lot coverage are two of the major bones of contention. There will apparently be a meeting between the planning commission and the Citizens Advisory Committee on June 27th but until all members of the advisory committee receive a copy of the WETAW proposal, it will be impossible to fairly consider and respond to this alternative plan.

MALLARD COVE VILLAGE: The Impact Statement Review Committee of ECC has reviewed the draft EIS for the proposed "Mallard Cove" development and has presented comments and recommendations to the May 21st meeting. The comments were approved with minor amendments and a letter was sent to the City Building Department.

The letter expressed an interest that the development should meet the intent of the Goals and Policies of the Shorelines Master Program. It stated that the proposed development would be acceptable only if changes are made to provide public access, such as a provision for a path for peds and bicycles along the shoreline. The letter also commented on the adverse impacts of the project in the areas of recreational use of the shoreline, traffic conditions, vistas of the lake and water quality.

It concluded with the statement that we are not opposed to the Mallard Cove Village so long as the recommended changes are incorporated into the proposal. It is imperative that we preserve public access to the shore of Lake Union.
