DARREL GROUTHAUS TO SPEAK AT NEXT GENERAL MEETING

The next general meeting of the Eastlake Community Council will be on Tuesday, November 20--7:30PM in the lunchroom of the Seward School (the small wood building). All Eastlake residents are encouraged to attend whether you are a member of the Community Council or not. The General meetings are always open to the public.

Our feature guest will be Darrel Grouthaus from the Department of Community Development who will address our questions and concerns regarding the reenactment of the Seattle Shorelines Master Program.

The Board of the Community Council is concerned (as are many Eastlake residents) about the use of "upland lots", It is proposed that the land across the street from the shoreline will be governed by underlying zoning codes—in Eastlake that means much commercial and manufacturing zoning codes could apply. And in the accompanying environmental impact statement, the East side of Fairview Ave. is the example of an area appropriate for office building and hotel development.

Yes folks, this makes us a little nervous. For years we have been able to monitor development in Eastlake through use of the Shorelines Management Act. This might change... and if you are concerned about the neighborhood development pattern, here is the time, the place, and the person who should hear those concerns.
