OCTOBER MEETING TO BE HELD AT SEWARD SCHOOL

There will be a general meeting of the Eastlake Community Council on October 15, and we have Seward School back again as a meeting place. Mike Feeney, Principal of Seward, has given us permission to use the staff lunchroom from 7:30 to 9:00 each evening that the School is open for special events, or for PTA meetings. Those dates and events over the next three months are:

> Wednesday, October 15 - - Open House Wednesday, November 5 - - Crafts Night Friday, December 5 - - Holiday Boutique

We regret having to give up our regular schedule of general meetings on the third Tuesday of each month, but the benefits of having Seward clearly outweigh the inconvenience of switching meeting nights.

The program for this Wednesday will includ presentations from <u>METRO</u> and the <u>Seattle Transit Alliance</u>. The <u>METRO</u> representative will discuss the Transit 1990 plan, and how <u>METRO</u> plans to fund it. One proposal is to raise the sales tax, which was defeated in September, but will be back on the ballot in November.

The Seattle Transit Alliance will offer some alternatives, including Initiative 21, which was ruled off the Fall ballot by a court decision.

Also on Wednesday will be a short presentation by John Wall, Eastlake's planner in the City Office of Neighborhood Planning.

John will describe the <u>Department of Community</u> <u>Development's</u> plans for new zoning policies in Eastlake's multi-family residential areas and in business or manufacturing areas. Members of the

Eastlake Technical Advisory <u>Committee</u> (TAC) will also be on hand to explain how renters, and community business people work with our planner on the project. John Wall will provide handouts on the recommended plan, which should be useful for study as a prelude to our November 5th meeting.

That meeting will be primarily devoted to a discussion of the city's recommendations for zoning in the Eastlake area. It will be an opportunity to express opinions about the shape of our neighborhood in the future.

The meeting this Wednesday will also take up regular business. We urge you to join with your neighbors and to speak your mind.
