# EASTLAKE COMMUNITY GENERAL MEETING SEWARD PUBLIC SCHOOL OCTOBER 19 . 7:30 P.M.

MARK YOUR CALENDARS! Yes, the summer recess is over, and its time to get Eastlake's "wheels in motion" for the upcoming year. We're pleased to say that we've been able to schedule our entire 1983 meetings at the Seward Public School (on Louisa and Boylston). And what's better yet, they will be held at the same time and place each month. So, mark your calendars for the third Tuesday of each month, at 7:30 P.M. (There is only one exception. Due to the holidays, in December, the meeting will be held on the second Tuesday of the month.) Here's the resulting calendar:

A VARIANCE FOR A MOORAGE DOCK IN WATERWAY NO. 10 HAS BEEN DENIED. The proposed dock, to be situated in front of Lynn St. public park (across from Pete's), and on the south side of the Union Harbor Condominiums, was opposed unanimously by those attending the recent public hearing, and the variance required was subsequently denied. This is a classic example of how some of the questionable developments in this area just seem to pop up, overnight!! This particular project was apparently recommended by the Department of Construction and Land Use, and not in the best interests of the condominium owners nor the neighborhood. It was designed to help the conominium developers around the public access requirement for the dock already in place on the south side of their building, and ultimately allow them to secure their building in a manner so as not to allow public access. We were wurprised to see that there was only 10 days notice required per city regulations for projects like this. To make matters worse, the City didn't get unput from any of the communities or neighbors, tried a quick-hit bulletin posting notice technique, with a public hearing scheduled, or course, at 9:30 A.M. on a weekday in downtown Seattle. Thankfully, everybody (including the Engineering Department and the Police Department) opposed the idea, which left the Department of Construction and Land Use holding an "empty" bag. We don't have to worry about this one for a while, but beware of this type of activity in the future. Keep a lookout for those inconspicuous telephone pole notices, any any questionable new developments going in that you may not have heard about. If you have questions, call the Department of Construction and Land Use at 625-5200.

TWO NEW DEVELOPMENTS ARE UNDER CONSIDERATION ON FRANKLIN AVE. E., after several months of inactivity in our community. One permit is the addition of two units at 2355 Franklin Ave. E., near Seward Public School. The other consists of the demolition of one small house to make way for an addition of four units at 1925 Franklin Ave. E., at the south end of our community. If you have queations about these or any other permits, the Department of Construction & Land Use office on the fourth floor of the Municipal Building (625-5200) and give you information. Or, easier yet, bring it up at our next monthly meeting, scheduled on Tuesday, October 19, at 7:30 P.M. in the Seward Public School.



AHHH...SUCH PEACE AND QUIET. We've been informed that the State is considering resurfacing the Ship Canal Bridge in the near or medium-range future. If you'll recall, the Evergreen Point Bridge was recently repaved with an open-graded asphalt overlap that has substantially reduced the vehicle noise emitted from the bridge. The Ship Canal Bridge has no noise-reducing berms or buffers, and because of the concrete surface on both levels, causes a tremendous amount of noise interference in Eastlake. The Eastlake Community Council is writing a letter to the state to request they pave the Ship Canal Bridge with the new sound-absorbing asphalt when the repaving takes place. We strongly urge you to do the same. In fact, it would be wise to state that if the portion of Interstate 5 which runs through Eastlake is also under consideration of repaving in the future, the new sound-absorbing asphalt should also be mandatory.
