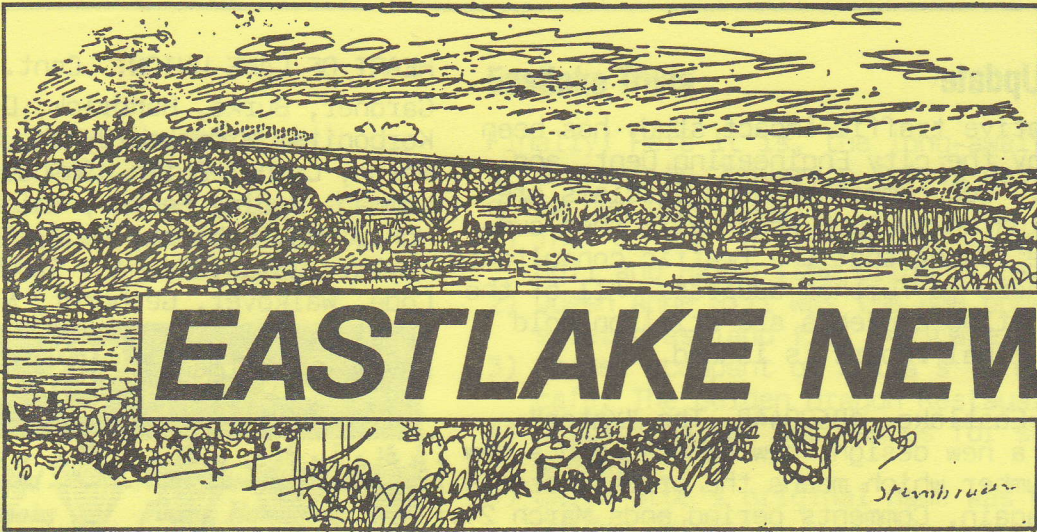

## Land Use Update

The cumulative traffic impact study has been reviewed by the city Engineering Dept. and the E.C.C. Our comments and criticisms are being evaluated by DCLU which will then summarize the issues that the traffic consultants (T.D.A.) need to further address. All of the 6 participating projects are still on hold until the final report is issued.

NEW! 2343 Eastlake. #8600448. The "Yates" bldg. has a new design, new owners, and a new project number which means the process starts all over again. Comments period ends March 21.

NEW! 1910 Fairview. #8601115. Another 5 story office bldg. w/2 levels of basement parking. Comment period ends April 1, the E.C.C. will get this date extended to April 16.

NEW! Corner of Louisa and Eastlake. #8600380. 5 retail shops (including laundramat) and flower shop. Height is unknown but it looks low. Could this actually be a building the E.C.C. can support?? No comment period set.

NEW! 214 E. Galer. #8600097. A 2 story office bldg. w/ basement parking and potential 3rd story addition. Comment period is over.

2048 Fairview. #8505493. A 29 unit condo. The E.C.C. is meeting with the developer in conjunction with Floating Homes.

Hal's Shell Station @ 2300 Eastlake, #8502300, has been appealed to the City Council by the E.C.C. No date has been set yet.

Mini Warehouse @ Franklin and Blaine. The city has approved  $\frac{1}{2}$  of the project. Appealed to the City Council by the developer and the E.C.C. (he wants more, we want less).

Fairview street vacation hearing (#CF 288648) has been postponed until March 26th.

Neighborhood Commercial Area vote by the fall council is due on March 31st. Calls to Council members will be organized at the March meeting.

There seems to be no end to development in Eastlake. Be at the March meeting so we can make an impact upon the new head of the Dept. of Construction and Land Use, Holly Miller.

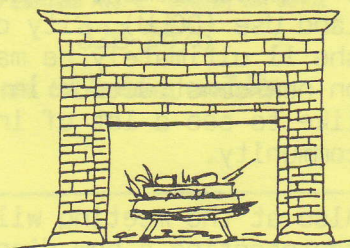
## New Member News

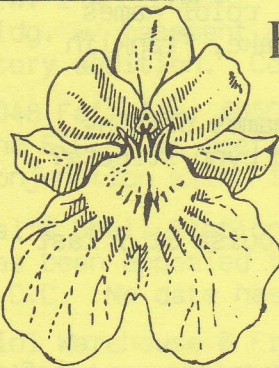

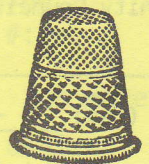
