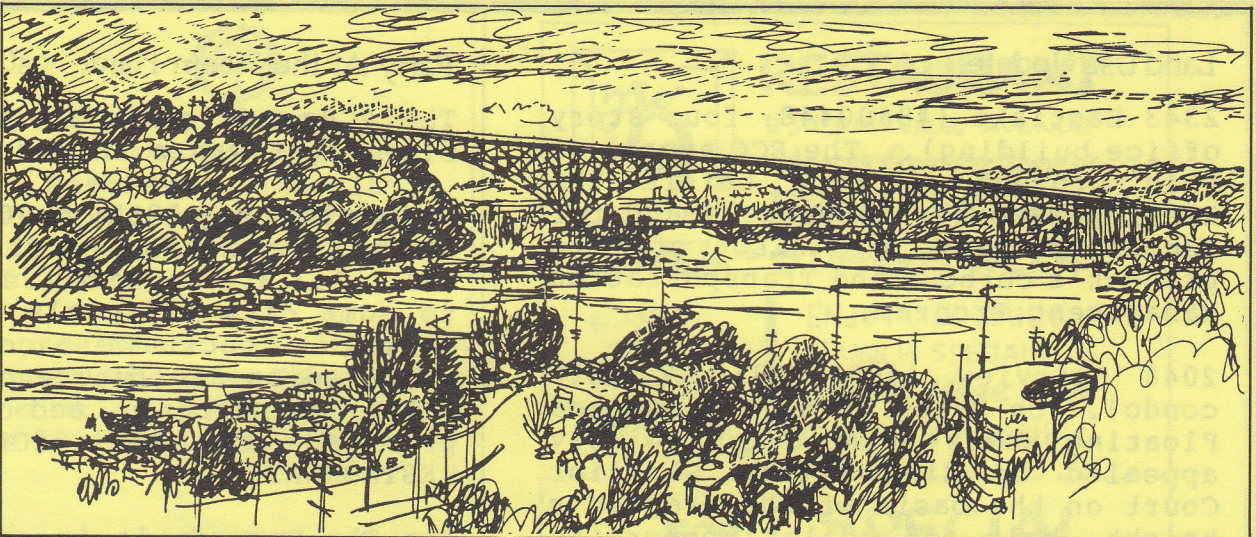

## Land Use Update

2343 Eastlake (#8600448: four story office building). The ECC appeal of this project is back before the Hearing Examiner after a remand for reconsideration by DCLU of the project's curbcut and Transportation Management Program.

2048 Fairview (#8505493: 32 unit condo). On March 10th, the ECC and Floating Homes Association jointly appealed to King County Superior Court on the basis of the project's height, bulk and scale incongruity with existing, desired or expected surrounding development. Fundraising for this appeal continues.

1926 Fairview (#8702317: 35 unit condo). The official SEPA comment period ended April 27th, but letters will still be accepted by DCLU. At this time, the ECC has formulated no official position.

**INDUSTRIALS ZONING.** City Council is currently considering zoning changes which will affect the northern and southern sections of our neighborhood. The ECC has a number of serious concerns with some of the height standards and zoning classifications of the existing recommendations. A Technical Advisory Committee has been formed.

**SOUTH LAKE UNION PARK.** The Seattle Parks Department will be holding a Open House at the Olympic Room of the Seattle Center, Tuesday, May 12th 5:00 PM to 9:00 PM. Nine design concepts will be revealed. Comments will be solicited.

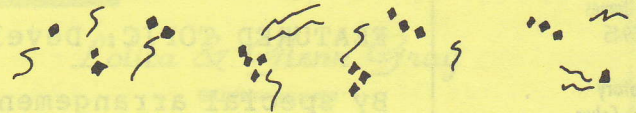

Wednesday, May 13th, 5:30 -- 8:00 PM, at the Steam Plant. Attire: respectable. All are welcome. Look forward to some city officials, a touch of music, cocktail conversations centered on the future of the Steam Plant structure and appetizers provided by our ROANOKE EXIT RESTAURANT.

For The Record: it is expected that the Steam Plant will be taken off the City Light power grid in the near future. All PCBs have been cleaned from the storage tank and boiler equipment. The total City Light property at the somewhat triangular site is estimated to be 88,000 square feet (in comparison, Rogers Playfield is a rectangular 83,500 square feet).



## Hazardous Waste Day

CAN YOU IMAGINE anyone standing at one of our pocket parks and pouring a pan of dirty motor oil into Lake Union? That's exactly the scenario -- just a few minutes removed -- when toxics are poured into neighborhood gutters.

May 30th, 1987 has been proclaimed King County's "Hazardous Waste Disposal Day." Special this day is the opportunity to properly dispose of household hazardous wastes (engine oil, brake fluid, antifreeze; insect, weed and hair sprays; rust, spot and nail polish removers; drain, oven and rug cleaners; paint and paint thinners, metal and furniture polishes).

A neighborhood collection center will be located at 2343 Eastlake (the Yates Parking Lot) from 10 AM to 3:00 PM. Only labeled, non-leaking containers can be accepted.
